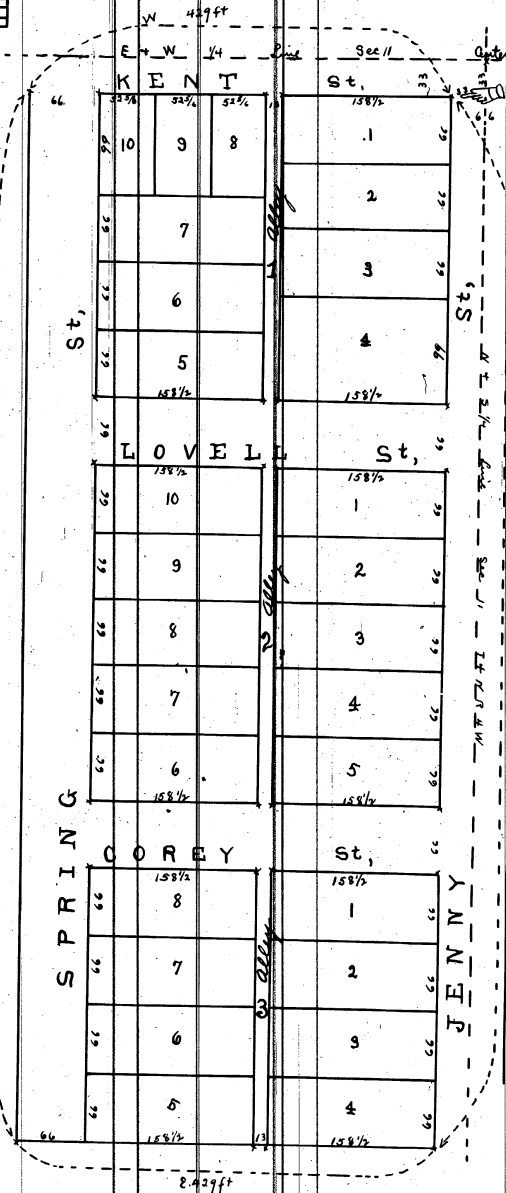
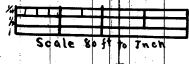


KENT'S ADDITION TO GRAND LEDGE
