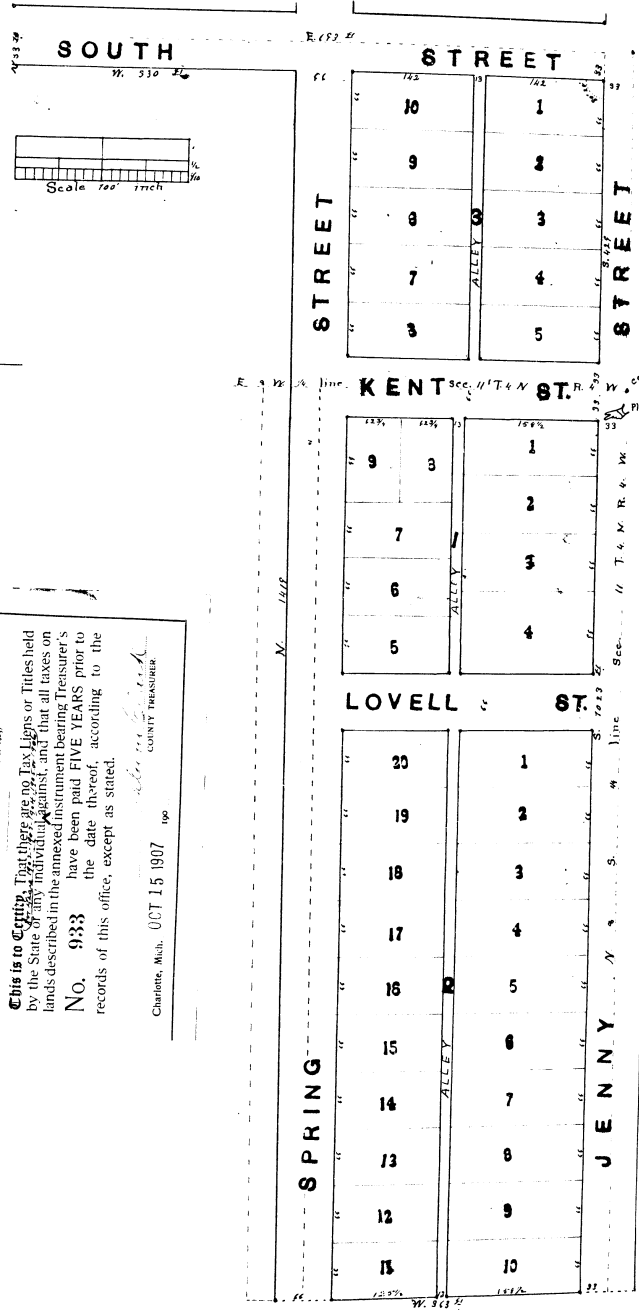


# Amended Plat of KENT'S ADDITION to Grand Ledge
